## General

- *The referenced time and periods of time, timing for billing shall be calculated according to the local time of Astana;*
- *Invoices for Issuers are issued on an annual basis;*
- *Invoices for Investors are issued on an annual basis;*
- *Invoices for the services provided are issued in USD to non-residents of the Republic of Kazakhstan;*
- *Invoices for the services provided are issued in KZT to residents of the Republic of Kazakhstan. Fee amount is converted to KZT at the current rate of the USD to KZT established by the National Bank of the Republic of Kazakhstan on the day of invoice for payment of services or date of service provision in the act of acceptance, whichever is earlier;*
- *In case AIX Registrar provides services for a relevant period in amount less than USD 15, the invoices for those services will be issued in the next consecutive period when the amount exceeded USD 15;*
- *AIX Registrar may pass through to Clients for reimbursement any other third-party costs it may incur;*
- *Amounts due shall be paid within 30 calendar days from the date of invoicing;*
- *Amounts do not include VAT or any other taxes;*
- *For clients (issuers and investors), which entered into relationship with AIX Registrar before 01.07.2023, this **AIX Registrar Fee Schedule** shall apply as of 01.01.2024;*
- *For clients (issuers and investors), which enter into relationship with AIX Registrar on or after 01.07.2023, this **AIX Registrar Fee Schedule** shall apply as of **01.07.2023**;*
- *If an issuer becomes a client of AIX Registrar after 1 January of a respective financial year, then the annual fees shall be prorated for the actual number of full months of the service.*
